

CASSIUS VENTURES LTD.

Management Discussion and Analysis For the Period Ended January 31, 2017

The MD&A of Cassius Ventures Ltd. (the "Company") has been prepared by management in respect of the three month period ended January 31, 2017, and should be read in conjunction with the condensed interim financial statements as of January 31, 2017 and related notes thereto of the Company. The Company reports its financial statements in accordance with International Financial Reporting Standards ("IFRS"). All figures are reported in Canadian dollars unless otherwise indicated.

Certain information included in this discussion may constitute forward looking statements. Forward looking statements are based on current expectations and entail various risks and uncertainties. These risks and uncertainties could cause or contribute to actual results that are materially different from those expressed or implied. The effective date of this report is March 27, 2017.

Description of Business

The Company is an exploration stage company focused on acquiring exploration and/or development stage mineral properties for the purposes of further exploration and development. The Company was incorporated on February 23, 2007 by Certificate of Incorporation issued pursuant to the provisions of the Business Corporations Act of British Columbia under the name "Cassius Ventures Ltd.". The Company currently trades on the NEX Board of the TSX Venture exchange under the symbol "CZ.H".

The Company continues its pursuit of a viable property of merit in conjunction with a financing to support the exploration or development of such a property.

Liquidity & Capital Resources

The financial statements have been prepared on a going concern basis, which assumes that the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of business.

The Company has yet to generate any revenues from operations and as at January 31, 2017, had an accumulated deficit of \$6,436,050 and a working capital deficit of \$182,568.

The Company's working capital balance currently limits the Company's ability to fund significant capital expenditures and operations. These conditions, along with other factors indicate the existence of material uncertainties that may cast significant doubt upon the Company's ability to continue as a going concern.

The continuation of the Company as a going concern is dependent on securing additional funding through equity or debt financing to (a) settle existing liabilities, (b) locate a property of merit to explore and develop and (c) support corporate overhead. Although management is of the opinion that sufficient working capital will be obtained to meet the Company's liabilities and commitments as they become due, either through the issuance of promissory notes or an equity financing, there is a risk that additional financing will not be available on a timely basis or on terms acceptable to the Company as market conditions have limited the availability of funds. In the event the Company is unable to arrange necessary financing, the Company may be forced to cease operations.

In the meantime, management have undertaken measures to mitigate ongoing expenditures, including waiving compensation accrued to management over the last 35 months and reducing other overhead costs as required. Ongoing costs are currently expected to be funded through the issuance of either promissory notes or securities of the Company.

Promissory Notes

As at January 31, 2017 and October 31, 2016, the Company had outstanding promissory notes totaling \$111,000. The promissory notes bear interest at 7% per annum, and are unsecured and payable on demand.

Interest incurred on the promissory notes for the three month period ended January 31, 2017 totaled \$1,958 (2016 - \$1,061).

Overall Performance

The following discussion of the Company's financial performance is based on the unaudited condensed interim consolidated financial statements for the three month period ended January 31, 2017.

At January 31, 2017, the Company had total assets of \$13,964 (October 31, 2016 - \$15,997), mainly comprising cash of \$13,003 (October 31, 2016 - \$15,059). The decrease in cash represents cash used for minimal operating activities of \$2,056 comprising regulatory compliance and listing fees, transfer agent fees as well as ancillary office costs.

Shareholders' deficit comprises share capital of \$5,968,027 (October 31, 2016 - \$5,968,027), contributed surplus of \$285,455 (October 31, 2016 - \$281,553) and a deficit of \$6,436,050 (October 31, 2016 - \$6,427,416). The increase in shareholders' deficit of \$4,732 results from the net loss for the three month period ended January 31, 2017 of \$8,634, partially offset by an increase to contributed surplus for share based payments of \$3,902, representing the fair value recognized from the vesting of stock options to directors, officers and consultant of the Company during the period.

The Company has a working capital deficit of \$182,568 at January 31, 2017 compared to a working capital deficit of \$177,836 at October 31, 2016.

Segmented Information

The Company operates in one business segment, being the acquisition, exploration and development of mineral properties.

Results of Operations

The following discussion and analysis of the Company's financial results of its operations should be read in conjunction with the Company's unaudited condensed interim financial statements for the period ended January 31, 2017:

During the three month period ended January 31, 2017, the Company reported a net loss of \$8,634 (2016: \$4,838). The increase in net loss from the prior period is a result of increased share-based payments recognized during the period, due to the stock option grants subsequent to January 31, 2016.

The net loss recognized during the three month period ended January 31, 2017 was mainly a result of \$2,231 incurred on transfer agent and regulatory filing fees (2016 - \$3,126) and \$3,902 of share-based payments in respect of the March and July 2016 stock option grants (2016 - \$305).

Since incorporation, the Company has no operating revenues as it is still in the acquisition and exploration stage.

Note 1 – As the Company has yet to secure a mineral related asset, the Company has no revenue to report during the financial reporting periods noted above.

The net income of \$1,399,231 in Q2 2015 is primarily due to the gain on sale of a previously held subsidiary with mineral claims in Nicaragua called Fortress de Nicaragua S.A. (“Fortress”) in April 2015, as the majority of balances written off from Fortress by the time of such sale comprised payables owing to the MEM. The net loss in Q3, Q4 2015 and Q1, Q2, Q3, Q4 2016 is reflective of minimal overhead expenditures being incurred by the Company since the sale of Fortress, while continuing its search for a property of merit alongside a prospective financing.

Critical Accounting Policies

A detailed summary of all the Company’s significant accounting policies is included in Note 3 to the audited annual financial statements for the year ended October 31, 2016.

Off Balance Sheet Transactions

There are currently no off balance sheet arrangements which could have a material effect on current or future results of operations, or the financial condition of the Company.

Subsequent Events

There are no subsequent events to report.

Outstanding Share Data

As at the date of this report, the Company has 10,217,248 common shares issued and outstanding.

As at the date of this report, there were 915,000 stock options outstanding.

b) Payments for services by related parties

As at January 31, 2017 and October 31, 2016, the Company owed \$28,215 to Atlantic Gold Corporation, a company with a common director and officer, being Robert Atkinson and Chris Batalha, respectively.

As at January 31, 2017 and October 31, 2016, the Company owed \$25,812 to Oceanic Iron Ore Corp., a company with an officer in common, being Chris Batalha.

As at January 31, 2017 and October 31, 2016, the Company owed \$4,000 to Chris Batalha, a director and Chief Financial Officer of the Company.

The amounts due to and from related parties other than those described in (c) below are non-interest bearing, unsecured and due on demand.

c) Promissory notes with related parties

As at January 31, 2017, the Company had \$40,500 (October 31, 2016 - \$40,500) of outstanding promissory notes issued to John Thomas, a director and the CEO of the Company, and \$10,000 (October 31, 2016 - \$10,000) of outstanding promissory notes issued to Chris Batalha, a director and the CFO of the Company. The promissory notes are unsecured, bear interest at 7% per annum and are payable on demand. Interest incurred on the promissory notes due to related parties for the three month period ended January 31, 2017 totalled \$891 (2016 - \$708).

Financial Instruments and Risks

Financial Risk Management

The Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework. The Company's financial instruments consist of cash, amounts receivable, accounts payable and accrued liabilities, amounts due to related parties and promissory notes payable.

Cash is designated as held-for-trading and carried at fair value. Amounts receivables are designated as loans and receivables and are measured at amortized cost. Accounts payable and accrued liabilities,

amounts due to related parties, and promissory notes payable are classified as other financial liabilities, which are measured at amortized cost.

Fair Value Measurement

A three-level hierarchy exists for fair value measurements based upon the significance of inputs used in making fair value measurements as follows:

- Level 1 – quoted prices in active markets for identical assets or liabilities.
- Level 2 – inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e.: as prices) or indirectly (i.e.: derived from prices).
- Level 3 – inputs for the asset or liability that are not based on observable market data.

At January 31, 2017, cash was categorized as level 1. The fair values of other financial instruments, which include amounts receivable, accounts payable and accrued liabilities, amounts due to related parties and promissory notes payable, approximate their carrying values due to the relatively short-term maturity of these instruments.

Financial Instrument Risk Exposure

The Company is exposed in varying degrees to a variety of financial instrument related risks. The Board approves and monitors the risk management processes.

Credit Risk

Credit risk arises from the potential for non-performance by counterparties of contractual financial obligations. The Company's exposure to credit risk is on its cash and amounts receivable. The Company's cash is being held with large financial institutions. Amounts receivable are comprised of GST receivable from the Government of Canada. The Company's credit risk is mitigated by maintaining its financial liquid assets with highly reputable counterparties. The maximum exposure to credit risk is equal to the fair value or carrying value of the financial assets noted above.

Foreign Exchange Rate Risk

The Company is not exposed to any significant foreign exchange rate risk.

Interest Rate Risk

As the Company's promissory notes bear a fixed interest rate, the Company is not significantly impacted by interest rate risk.

Liquidity Risk

The Company's cash are invested in business accounts which are available on demand. The Company manages liquidity risk by preparing and maintaining cash forecasts, which illustrate cash spent to date and cash needs over the short term. As at January 31, 2017, the Company had total current assets of \$13,964 (October 31, 2016: \$15,997). Contractual undiscounted cash flow requirements for financial liabilities as at January 31, 2017 and October 31, 2016 are presented below.

The Company's ability to continue operations in the normal course of business is dependent on several factors, including the ability to secure additional financing, all of which are uncertain.

Price Risk

The Company is not currently exposed to price risk with respect to commodity prices. The Company's ability to raise capital to fund exploration and development activities with a potential future project may be subject to risks associated with fluctuations in the market price of commodities.

Legal Proceedings

The Company is not involved in any legal proceedings.

Risks and Uncertainties

The Company is in the business of acquiring, exploring and, if warranted, developing and exploiting natural resource properties. Due to the nature of the Company's proposed business, the following risk factors, among others, will apply

Going Concern

The financial statements have been prepared on a going concern basis, which assumes that the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of business.

The Company has yet to generate any revenues from operations and as at January 31, 2017, had an accumulated deficit of \$6,436,050 and a working capital deficit of \$182,568, including \$111,000 owing through the issuance of promissory notes, which can be called on demand.

The Company's working capital balance and asset profile currently limits the Company's ability to cover its current liabilities or fund future significant capital expenditures and operations. These conditions, along with other factors indicate the existence of material uncertainties that may cast significant doubt upon the Company's ability to continue as a going concern.

Although management is of the opinion that sufficient working capital will be obtained to meet the Company's liabilities and commitments as they become due, either through the issuance of promissory notes or an equity financing, there is a risk that additional financing will not be available on a timely basis or on terms acceptable to the Company as market conditions have limited the availability of funds. In the event the Company is unable to arrange necessary financing, the Company may be forced to cease operations.

Key Personnel

The Company is dependent upon the services of key executives, including the directors of the Company and a small number of highly skilled and experienced executives and personnel. Due to the relatively small size of the Company, the loss of these persons or the inability of the Company to attract and retain additional highly-skilled employees may adversely affect its business and future operations.

Share Price Volatility and Liquidity

Publicly quoted securities are subject to a relatively high degree of price volatility. It may be anticipated that the quoted market for our shares will be subject to market trends generally, notwithstanding any potential success of us in creating sales and revenues. In addition, our shareholders may be unable to sell significant quantities of shares into the public trading markets without a significant reduction in the price of their shares, if at all.
